If there are changes in the facts from the previous filing then the statement must be published again. The statement must be published in an adjudicated newspaper (Anytown Daily News or City Observer) once a week for four consecutive weeks. The first publication must begin within thirty days of the date the statement was filed in the County Clerk's Office.

The filing fee for a fictitious business name statement is \$31.00 for one business name and one registrant and \$5.00 for each additional registrant or business name. You may visit our website at www.co.county.ca.us to print out a Fictitious Business Name Statement form and return it with the appropriate fees to Demo County Clerk & Recorder, PO Box 123, AnyTown, CA 12345 or come into our office at 100 Main St., Room 25, AnyTown, CA 12345 to file your statement.
